- A.) Consideration of Paying for ½ of the Installation of the Basement Drain Line Check Valve at 320 E. 9th Street. Alderman Randy Wyant suggested tabling this item to a future meeting in order to gather additional information. Council agreed.
- **B.)** Consideration running a Sanitary Sewer Line Lateral Crossing 8th Street for CY Electric at 115 E. 8th Street. Alderman Randy Wyant suggested tabling this item to gather more information and allow Superintendent Randy Stauffer to report findings. Council agreed.

APPROVAL OF BILLS:

A.) General Fund Bills for \$ 90,655.86. Alderman Scott Davis moved to approve payment of the general bills; second by Alderman Denis Fisher. MC 6-0. Alderman Aaron Kafer and Greg Houtzel did not respond to roll call.

NEW BUSINESS:

<u>A)</u> Consideration of Clock Tower repair bids. Scott Burge of Farnsworth reported that on December 17th, 4 bids were accepted and opened. The bids are to repair the clock tower by removing existing face brick and replace. He recommends accepting Stealth Mode Construction's bid and to decide whether to begin the project immediately at a total of \$134,340.00 or wait for better weather for a bid of \$123,396.00. Alderman Aaron Franks moved to approve Stealth Mode Construction's bid, not to exceed \$126,395.00, and give Mayor Dickey authorization to sign the contract; 2nd by Alderman Susie Tongate. MC 6-0. Alderman Scott Davis pointed out that \$65.000.00 would be paid out of the specified line item with the remainder paid out of the next budget.

Announcements: Mayor Dickey and City Clerk Carla Moxley wished the council and attendees a "Happy New Year'. Mayor Dickey congratulated Attorney Marc Miller and wife Nicole on their 35th Anniversary.

Adjourn: Alderman Dennis Pardick moved to adjourn; second by Alderman Susie Tongate. Council was polled with 6 ayes/ 0 objections.
