Alderman Dennis Pardick motioned to approve Alderman Scott Davis as Mayor Pro-Tem for this meeting, in the absence of Mayor Dickey: second by Brandon Roderick. Council was poled with 7 ayes.

Pledge of Allegiance: led by Alderman Dennis Pardick.

Mayor Pro-Tem Scott Davis read a short statement in tribute to Chief Eric Hyatt and then asked for a moment of silence in memory of Chief Hyatt's 11 years of service and dedication to the City of Gibson City. Mr. Davis asked that the council attend Chief Hyatt's services as a group, and announced that City Hall would be closed at 11:30 am on Wednesday, so that everyone could attend. Mayor Dickey is cutting his vacation short and will be back to attend the services. Visitation is scheduled for Tuesday at Lamb Funeral Home 4pm -8pm and Services will be at the American Lutheran Church on Wednesday at 11:30 am.

**Approval of Council Minutes**: Alderman Laura Miller motioned to approve the minutes of July 10, 2017; seconded by Alderman Randy Wyant. **MC 8-0**.

- **B.)** Alderman Dennis Pardick motioned to enter into Exec. Session to discuss the sale of property located at 303 N Jordan Drive; second by Alderman Brandon Roderick. MC 8-0.

- D.) Consideration of Ordinance (2017-O-11) authorizing the Sale of Real Estate located at 303 N Jordan Drive. Following Executive Session, Alderman Laura Miller motioned to approve the Sale of Real Estate located at 303 N Jordan Drive to Steve and Andrea Killian (Johnny on the Spot Port-a-Potties, Inc) for a price of \$16,000.00, reduced from \$20,000.00; second by Brandon Roderick. MC 7-0. Alderman Randy Wyant abstained from the vote, stating conflict of interest.
- E.) Consideration of Ordinance (2017-O-09) amending the Gibson City Municipal code to regulate Golf Carts. Alderman Randy Wyant motioned to approve Ordinance (2017-O-09) as presented with updates to include Off Road Recreational Vehicles; second by Alderman Brandon Roderick. MC 8-0.

# NEW BUSINESS:

A.)\_Consideration of a Special 2-day liquor license for Burgers and Beer in conjunction with Harvest Fest. Alderman Dennis Pardick motioned to approve a 2 day outdoor liquor license to Burgers and Beer located at 109 W 8<sup>th</sup> Street, in conjunction with the Harvest Fest between 11 am to midnight on Friday Sept 8 and Saturday Sept.9, within a fenced area and for a fee of \$1.00 and subject to the terms of the license issued; second by Alderman Randy Wyant. MC 7-0. Alderman Laura Miller abstained, stating conflict of interest.

**B.)** Consideration of City Pond improvements. Alderman Susan Tongate motioned to approve the City Pond Improvements for a total of \$34,950.00, to be paid from TIF funds, including hiring Don Unzicker to install a parking lot for \$7,000.00, approve purchasing a handicap fishing dock from VW Dock Company for \$18,500.00, approve rip-rap for the shoreline to be installed by Lee Excavating for \$4000.00 and to approve the other city pond improvements as presented; second by Alderman Randy Wyant. MC 8-0.

**C.)** Consideration of Harvest Fest Details. Alderman Randy Wyant motioned to approve the Harvest Fest Event as presented and approve a City contribution of \$1500.00 to be paid out of the city's advertising budget; second by Alderman Susan Tongate. MC 8-0.

**D.)** Consideration of Ordinance (2017-O-10), amending Sewer Rates. Alderman Doug Parsons motioned to approve increasing sewer rates by 25% effective with the next billing cycle; second by Alderman Randy Wyant. MC 7-1. Alderman Brandon Roderick voted against.

E.) Consideration of Ordinance (2017-O-12) approving and authorizing the Execution of a Tax Increment Financing (TIF) District Redevelopment agreement by and between the City of Gibson City, Ford County, IL and Johnny on the Spot Porta Potties, Inc. Alderman Dennis Pardick motioned to approve Ordinance 2017-O-12 as presented; second by Alderman Brandon Roderick. MC 7-0. Alderman Randy Wyant abstained, stating conflict of interest.

## Announcements/Comments:

Alderman Susan Tongate informed the council that she has ribbons to be placed on the light poles downtown in honor of Chief Eric Hyatt and asked that Randy and his crew assist with putting them on the poles prior to Chief Hyatt's funeral on Wednesday.

Randy Stauffer noted that a tree that had been recently cut down had a plaque on the tree with the Ehnfield name on it. It was decided to give the plaque to his daughters.

There has also been a request to plant a tree in the honor of Bob Crossman and place a plaque.
