**A RESOLUTION
AUTHORIZING PAYMENT TO GIBSON AREA HOUSING REHAB
FOUNDATION**

WHEREAS, On or about August 12, 2021 Gibson City endured 9 inches of rainfall in a 6 hour period resulting in flash flooding and related devastation; and

WHEREAS, the Gibson Area Housing Rehab Foundation (GAHRF) has historically been part of the community and instrumental with charitable assistance for the rehabilitation of housing in Gibson City; and

WHEREAS, during the recent flash flood the GAHRF in coordination with the City, has been providing needed assistance to property owners with the rehabilitation of residential and other property in the City; and

WHEREAS, to continue its mission in Gibson City, GAHRF requires additional funding to benefit of the residents of Gibson City; and

WHEREAS, the Mayor and City Council this date have placed consideration of this Resolution on its regular agenda, considered various reports by staff and elected officials, input from the public, and representations by representatives from GAHRF and have determined it in the best interests of the City to provide a grant of funds to GAHRF to continue providing rehabilitation relief to the residents of the City of Gibson all as provided herein.

NOW THEREFORE, BE IT RESOLVED by the City Council and Mayor of the City of Gibson as follows:


1. That, with agreement by GAHRF to continue to provide rehabilitation services to the Citizens of Gibson City for the purpose of pursuing recovery from the flash flood event of August 12, 2021, the City hereby grants to GAHRF the sum of \$250,000⁰⁰.


2. The recitals contained above are adopted as findings of fact and by reference are incorporated herein.


