**ORDINANCE NO. 2002-0-26**

**AN ORDINANCE ADOPTING A REVISED CODE OF ORDINANCES OF THE CITY OF GIBSON CITY, FORD COUNTY, ILLINOIS.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GIBSON CITY, FORD COUNTY, ILLINOIS, THAT:**

**SECTION 1: Amendment.** The following exhibit shall be "**The Revised Code of Ordinances**" of the City of Gibson City, Ford County, Illinois" and shall be as follows:

**SECTION 2: Severability of Provisions.** Each section, paragraph, sentence, clause and provision of this Ordinance is severable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of the Ordinance, nor any part thereof, other than that part affected by such decision.

**SECTION 3: Effective.** This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.

**SECTION 4:** Passed this 11<sup>th</sup> day of November, 2002 by the Mayor and City Council of the City of Gibson City, Ford County, Illinois, and deposited and filed in the office of the City Clerk in said City on that date.
